I. DUTIES AND RESPONSIBILITIES

Directs financial activities of the organization by performing the following duties personally:

- Prepares reports that summarize and forecast company business activity and financial position in areas of income, expenses, and earnings based on past, present, and expected operations.
- Coordinates the monthly closing procedures.
- Directs preparation of budgets.
- Directs determination of depreciation rates to apply to capital assets.
- Records and prepares information for audits. Prepares reports required by regulatory agencies.
- Maintains all equipment leasing documents and handles equipment lease payments.
- · Assist in long-range planning and strategy.
- Assist Plant Manager as needed.
- Other duties as assigned.

II. EDUCATIONAL AND OTHER SKILL REQUIREMENTS

Bachelor's degree in Accounting from four-year college or university; and 5 –l0 years experience in accounting, preferably in manufacturing environment. 2-4 years supervisory experience. Knowledge of inventory, cost accounting and general accounting, and financial statements. To perform this job successfully, an individual must be able to perform each essential duty satisfactorily.
