### Guarantee

This puppy is guaranteed to be in good health to the best of Arizona Ground Hounds' knowledge at the the time of sale.

Upon receipt this puppy is guaranteed to be free from life threatening or genetic diseases for up to 6 months. It is required for a licensed Veterinarian to examine the puppy within 72 hours of purchase or there will be NO GUARANTEE on Seller's Part.

This contract does NOT cover internal or external parasites or viruses.

If puppy is found to be unfit for purchase. (illnesses must be life threatening)

Arizona Ground Hounds must be notified by the Buyer and Arizona Ground Hounds must receive a written statement from a licensed Veterinarian that states the puppy has a life threatening illness that is genetic or that was contracted by the puppy before the time of purchase before any replacement will be made.

In the event of the death of the puppy a necropsy must be performed to determine the cause of death and documentation must be given to Arizona Ground Hounds to show that the death was caused by a life threatening genetic disease and that the puppy got this life threatening disease before the time of purchase. Arizona Ground Hounds will not be responsible for any charges for the necropsy or for any costs for medical care by a Veterinarian.

We offer NO CASH refunds. If a replacement is to be made Arizona Ground Hounds will replace the purchased puppy with another puppy of equal value when a puppy is available. In the event of any replacement all Veterinarian documentation, necropsy documentation, AKC paperwork for the

deceased puppy, and health records must be received by Arizona Ground Hounds within 72 hours along with the puppy.

At the time of sale, Arizona Ground Hounds has given the appropriate vaccinations and has given the puppy at least one dose of de-wormer. The Buyer will be given a vaccination record. Buyer agrees to maintain the health of this puppy. The Buyer agrees not to use this puppy for breeding. The Buyer agrees to have the puppy neutered or spayed by the time the puppy is 6 months old.

Arizona Ground Hounds does NOT guarantee the size, weight, coat, color, skin conditions, temperament or training ability of this puppy/dog.

All Deposits are non-refundable.

Puppies are to be paid for in full at the time of pick up, or, the puppies are to be paid for in full at least 2 weeks prior to shipping.

We do not accept checks for final payment on puppies.
